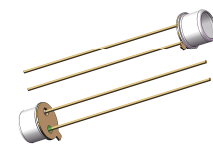

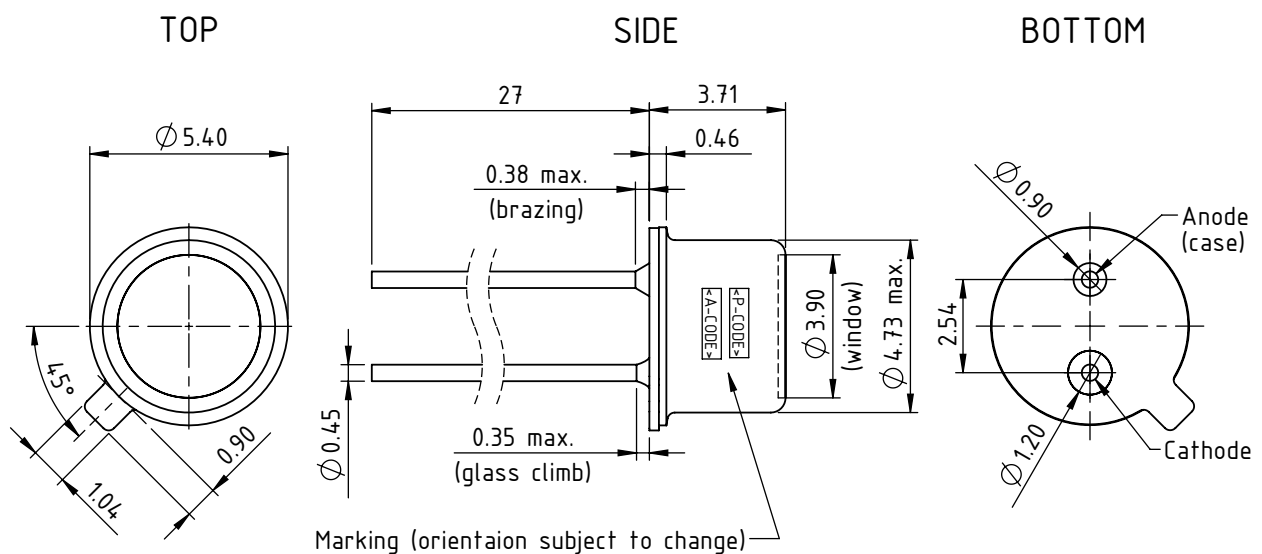

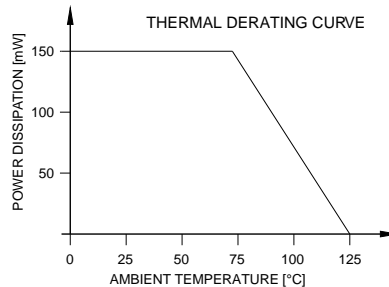


Figure 1: Maximum power dissipation with respect to temperature
